# Purpose

The purpose(s) for which we are processing your personal data is(are):

Your personal data will be collected to enable you to login and input information to the CCIAF system on behalf of your public sector organisation Personal data that identifies individuals will not be published externally, nor will data be shared that identifies individuals or their organisations, without prior agreement from the information provider

# Legal basis of processing

The legal basis for processing your personal data is:

- processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the data controller. In this case that is to improve the governance and standards of practices across the government Commercial Function

## Recipients

As your personal data will be stored on our IT infrastructure it will also be shared with our data processors who provide email, and document management and storage services.

### Retention

Your personal data will be kept by us for up to 7 years,

#### **YOUR RIGHTS**

You have the right to request information about how your personal data are processed, and to request a copy of that personal data.

You have the right to request that any inaccuracies in your personal data are rectified without delay.

You have the right to request that any incomplete personal data are completed, including by means of a supplementary statement.

You have the right to request that your personal data are erased if there is no longer a justification for them to be processed.

You have the right in certain circumstances (for example, where accuracy is contested) to request that the processing of your personal data is restricted.

You have the right to object to the processing of your personal data where it is processed for direct marketing purposes.

You have the right to object to the processing of your personal data.

### **COMPLAINTS**

If you consider that your personal data has been misused or mishandled, you may make a complaint to the Information Commissioner, who is an independent regulator.
